In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 14 tCO2e by 2028. This is a reduction of 25%

Carbon Reduction Projects

The following environmental management measures has been planned and some of them been implemented to achieve our commitment.

- 1. Remote and hybrid work for our staff to reduce our organizations' commuter emissions: This has been implemented to few of our staffs in this year and planned to use it for some other staffs in next few years.
- 2. Provide Shuttle services to our staff to reduce the number of cars on the road and will reduce our taxi costs.
- 3. Include net zero target and our commitment as part and parcel of our training programmes to ensure all our staff are well informed and understand the scope of sustainability and how activities can help us towards our net zero target.
- 4. Highlight our commitment to net zero with our customers and include necessary measures into our bid submissions and contracts.
- 5. Check net zero compliance of all our suppliers and actively discuss the ways to reduce the emissions in any purchasing goods or services.
